Dr. Sunita Srivastava , Director AIMSRS presented AIMSRS's achievements & activities since the last IQAC Meeting held in October,2021. As per Times B-School Survey 2022 published on February 24th 2022, the Ranking of AIMSRS improved from 42th to 40th among the top private B-Schools in India. The Institute also improved its ranking among the top 100 B-Schools in India from 58th to 55th.

As per Times B-School Survey 2022 dated 10th March 2022, AIMSRS is ranked 6th top private B-School in Mumbai.

Suggestions made by Dr Chandramauli Dwivedi

1. The fact of 100% Placement should be promoted on social media in an attractive way for the promotion of the Institute. Testimonials & Videos should be included as part of the social media campaign. A standard format should be made to showcase the placed students in different organisations with their logos & photographs of the placed students.
2. A formula “BAP” (Branding-Admission-Placement” should be used as the central theme of the Institute’s promotion strategy which he hoped would bring in overall growth of the Institute.
3. The Alumni Association should be registered as soon as possible
4. The Institute should aim at getting A grade in NAAC & obtain 3.70 marks to be able to apply for the Autonomous Status.

Suggestions made by Mr Regan Muchhala, Entrepreneur

1. The importance of outbound training programmes should be emphasized
2. He shared his experience of new additions to his Venture “Juice on Wheels”

Suggestions made by Mr Yatin Shah, Alumni





ITEM 6
